CIRCULAR

Subject: Mode of fee payment to RCI for registration in Central Rehabilitation Register (CRR) by NEFT/RTGS only - reg.

Presently, the Council is accepting fee for registration in CRR from the individuals through demand drafts/bankers cheque/pay orders. It has been experienced that this process involves inordinate delay due to postal service, depositing with bank for clearance of the instruments. Sometimes, demand drafts also get expired due to this outdated and lengthy process.

2. To overcome this delay and speed up the process of remittance and speedy realization of funds, it has been decided to discontinue the existing practice of submitting demand drafts and in place of it, to introduce a new system to accept payments through RTGS/NEFT directly to the Council's Bank Accounts.

3. The details of bank accounts of the Council for depositing the registration/renewal fee are given as under:

4. This fee through RTGS/NEFT may be deposited in any computerized branch of the concerned banks throughout India.

5. Once money is deposited in any branch of PNB or Canara Bank, the candidates are required to collect the transaction number from the concerned branch, where the money has been deposited and provide the details of it, alongwith the depositor's copy of pay-in-slip alongwith their concerned application. It has been told by the bankers that transaction number is not provided when the transfer of money is done in the similar bank, so in particular for these two banks, the candidate has to request to the Bank Cashier to provide him the transaction number.


