As you are aware National Institute for the Empowerment of Persons with Intellectual Disabilities (Divyangjan) is an Autonomous body working under the administrative control of Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Govt of India, New Delhi.

It is to bring to your kind notice that, we have floated various tenders for Hiring of Human Resources (Manpower) on GeM Portal.

After finalizing the bid, orders were placed with L-1 agencies and many agencies did give acceptance. However, these agencies invariably after accepting the work order did not carry out the work, a list of such agencies and specific details regarding the tenders are given below.:
