1. M.A., M.Ed.Spl. with 3 years' Experience in HRD (or)
2. M.A., B.Ed.Spl. with 5 years' Experience in HRD (or)
3. M.A., D.Ed/Dip.in Spl.Edn with 8 years' Experience (or)
4. Any officer of Central/State Govt./University not below the PB of 4600/- (or)
5. Principal / Headmaster of recognised Special/Regular school with 10 year Experience.

The Teacher Training Institutes are required to nominate 3 Names of CLO's, as per specified qualifications latest by 4<sup>th</sup> May 2017 by return mail in the prescribed form.

**Note:** All eligible Professionals working in the field of Disability Rehabilitation can submit their Bio-data to Examination Cell NBER - NIEPMD, with their willingness to work as CLO and any assignment related to Examination.

Sl.No	Particulars	Rates of Remuneration
1.	Honorarium for CLO	Rs.500/- Per day.
2.	TA For out stationed CLO	<b>Journey by Train:-</b> 1. A.C II Tier Class by Train (only on presentation of tickets) Not exceeding more than 300 Km within the State.
4.	Local Conveyance Allowance	<b>Journey by Road:-</b> Actual fare by any type of public bus including air conditioned bus. Journey by auto rickshaw, own scooter, motor cycle etc. @ Rs.8/- per km Journey by car, own car etc. @ Rs.16/- per Km. Subject to the maximum of Rs.500/- per day. <b>NOTE:</b> Local transport by Auto/ Taxi not exceeding 100 kms for the total journey under taken (including all days). TA to the CLO is subject to maximum of Rs. 3000/- per TTI's
5.	Dearness Allowance	Rs. 200/- per day CLO is also eligible for the DA including for the day journey performed for out station examination.
6.	Accommodation for CLO	Rs. 850/- per day.
