- **Author guidelines for paper submissions**
- **The Journal and requirements for submission of articles for publication:**

Challenging Exclusion: The International Journal for the Promotion of Inclusive Societies is an international peer reviewed journal which publishes papers which promote more inclusive and sustainable approaches to supporting the education and welfare of individuals from all marginalized groups. This includes those with disabilities, special educational needs, or others who have been excluded because of gender, religion, poverty or their designation according to scheduled tribe or caste. The journal's editorial board welcomes contributions focusing on any aspect of policy, provision or practice that relates to these issues and will publish both research papers and those which are philosophical or discuss policy issues in depth. Papers will only be considered for publication in *Challenging Exclusion: The International Journal for the Promotion of Inclusive Societies* on condition that they have not yet been published and are not being considered for publication elsewhere. Authors must confirm in writing the originality of their work when submitting papers for consideration and must ensure that all necessary permissions to publish have been obtained. Successful authors will be required to sign a copyright assignment agreement and to provide brief biographical notes for inclusion in the journal. All papers considered for publication will be subjected to rigorous peer review initially by the editor and then by two further reviewers who have expertise in the subject area. Papers reporting empirical research must contain a clear indication of the rationale for the research; the methods used; the findings; and the implications of these for future practice and further research. Authors must ensure and give a clear indication that their work has been conducted ethically.

- **Presentation of manuscripts**

Manuscripts must be submitted in the following format and failure to comply will result in rejection. All papers should be of between 4000 and 6000 words in length including references. *Challenging Exclusion: The International Journal for the Promotion of Inclusive Societies* does not use footnotes or appendices. Papers should be double spaced and presented in Times New Roman 12pt font. Tables, graphs, diagrams and flow charts or examples of recording formats can be included in articles as Figures or Tables and must be numbered and provided on separate sheets with a clear indication of where they should be located in the text. Papers should be written in plain English in order to be accessible to a diverse readership. When technical terms are used, the writer should provide brief explanations of these supported by contextual descriptions or examples. Authors must avoid language that can be seen as discriminating against people on account of disability, race, class, caste, tribal status or gender.

All papers must be accompanied by an abstract in English of a maximum of 250 words in length. This should describe the context and focus of the paper, and make reference to methods used, findings and conclusions. A second abstract may be submitted providing the same detail in any appropriate Indian language. Authors must also provide a maximum of six key words which describe features of the paper. Authors should send two copies of their paper, one containing all details of the author's affiliations and a second with all identifying features removed.

- **References**

References should be easily accessible. Sources should be indicated in the manuscript by giving the author's surname with the year of publication in brackets. Page numbers should be given for direct quotations used in the text. Full details of all references must be listed in alphabetical order of authors' names at the end of the article. All references must be provided in the approved American Psychological Association APA style.
