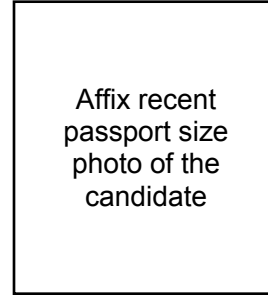

Instructions to the Candidates

1. Dates to be Remembered:
 - Last date for submission of filled application – **15th June 2018**
 - Entrance Exam – **27th July 2018**
 - Commencement of course – **20th August 2018**
 2. The filled application form should reach NIEPMD on or before 15th June 2018.
 3. Copy of necessary certificates should be attested and attached with the application form.
 4. In the case of candidates who have obtained their PG Degree from Universities other than University of Madras, the marks secured by them in the External Examination of their Post-Graduation Degree plus Entrance Exam marks will be taken into consideration to arrive the merit list. Hence, candidates from other Universities **will have to ensure** that their PG Statement of Marks **has bifurcation of Internal & External Examination** (as per the Admission Guidelines of University of Madras). The statement of marks without the bifurcation will not be considered.
 5. After screening the applications, the list of candidates eligible for the entrance examination will be uploaded in the Institute's website within ten working days.
 6. The Hall Tickets (that is filled and submitted along with the application form by the candidate) duly signed and sealed by the Head of Department will be sent to the eligible candidates. The candidates are advised to produce their hall tickets on the day of their entrance exam, failing which they will not be permitted to write their exam. Any dispute regarding the same, will be at the discretion of the Director, NIEPMD.
 7. Candidates who are unable to produce their final year / semester Statement of Marks at the time of application **MUST produce the Statement of Marks for all the years / semesters** of their Post-Graduation Degree, on the day of Entrance Exam. As the PG Marks accounts for the Merit List, the candidates without their complete Statement of Marks will not be permitted to write their Entrance Exam.
 8. On the day of Entrance Exam, the eligible candidates must report and register at NIEPMD between 09.30 to 10.00am with their original certificates and hall ticket.
 9. Verification of original certificates will be done between 10.00 am to 01.00 pm on the same day.
 10. The Entrance Exam will be held between 02.30 to 03.30 pm.
 11. Usage of mobile phones and electronic gadgets are not permitted inside the exam hall.
 12. The Merit List of the entrance exam will be uploaded in the Institute's website within five working days. No personal intimation will be sent to the candidates.
 13. The reservation policy and admission guidelines prescribed by the University of Madras will be followed in the admission procedures. The Institute will adopt any new amendments that are made by the University of Madras for the academic year 2018-19.
 14. After the publication of the Merit List, the shortlisted candidates will be expected to take their admission at the earliest. In any case, the shortlisted candidates those do not opt to join the course are requested to submit a letter for the same, addressing to the Director, NIEPMD by e-mail (only through the e-mail mentioned in the application form) or in person.
 15. The dates mentioned above are subject to changes. Any modifications will be uploaded in the Institute's website.
 16. Apart from the norms and regulations of the University of Madras, the criteria of the Institute will be at the discretion of the Director, NIEPMD.
