Sub: Mode of Fee payment to NBER by Institutions through NEFT only-reg.,

Presently the NBER is accepting fees for registration through NEFT only. It has been experienced that the DD process involves inordinate delay due to postal services, depositing with bank for clearance of the instruments.
