### APPROVED RATES OF REMUNERATION ADMISSIBLE FOR PRACTICAL EXAMINATION:

Sl. No	Particulars	Rates of Remuneration
1.	Honorarium for External Examiner (EE)	Rs. 10/- per candidate, per subject (paper) (to the minimum of Rs. 100/-)
2.	Honorarium for Internal Examiner (IE)	Rs. 10/- per candidate, per subject (paper) (to the minimum of Rs. 100/-)
3.	TA For out stationed External Examiner only	<b>Journey by Train:-</b> 1. A.C II Tier Class by Train (only on presentation of tickets) (nearest location in the concerned state)
4.	Local Conveyance Allowance	<b>1. Journey by Road:-</b> a) Actual fare by any type of public bus including air conditioned bus. b) Journey by auto rickshaw, own scooter, motor cycle etc. @ Rs. 8/- per km c) Journey by car, own car etc @ Rs.16/- per Km d) Subject to the maximum of Rs.500/- per day  TA to the External Examiner is subject to maximum of Rs. 3000/- per TTI's
5.	Dearness Allowance payable at all places for practical examination (only for External Examiners)	Rs. 200/- per day  (External Examiner is also eligible for the DA including for the day of journey performed for out station of examiner.)
6.	Accommodation for External Practical Examiner	Rs. 750/- per day
