#### Agenda point 52.03:

Approval for waiving off fees collected for HRD and other services from persons with disabilities at NIEPMD, Chennai and the CRCs under the control of NIEPMD, Chennai

### **Decision**:

The Executive Council approved the following for NIEPMD, Chennai, CRC-Kozhikode, CRC, Port Blair, Andaman and Nicobar Islands & CRC-Shillong:

- Waiving of full course fee in respect of Divyangjan having UDID card or enrolled for UDID or having disability certificate irrespective of percentage of disability of various courses in NIEPMD, Chennai and CRCs under NIEPMD from the year 2022-23 (Including those who are doing two years or more courses and are in their 2<sup>nd</sup>/ 3<sup>rd</sup>/4<sup>th</sup> year)
- Waiving of service charges for beneficiaries having UDID card / enrolled for UDID card or having disability certificate irrespective of percentage of disability w.e.f. 1<sup>st</sup> January, 2023.
- 3. Starting the dedicated counter for assistance in UDID card enrollment w.e.f. 1<sup>st</sup> January 2023 with help of existing staff at the registration counter.
- 4. Waiving off the registration/ OPD charges up to Rs. 50/- for all the patients irrespective of the disability status.
- 5. Service facilities to be provided on Saturday and Sunday w.e.f 1<sup>st</sup> January, 2023 with existing staff on a rotation basis.
