#### **IMPORTANT NOTE:**

- i. The above consultant positions will be filled purely on contractual basis.
- ii. Engagement will be governed by the rules and regulations, terms and conditions of the engagement of the Institute presently in force or as may be framed, amended, altered or extended from time to time by the Ministry.
- iii. The term of engagement shall ordinarily be for an initial period not exceeding 3 years. It may be extendable up to maximum 5 years. Beyond 3 years it may be extended with the approval of GC, provided in no case shall it be extended beyond 5 years.
- iv. The selected candidate will be entitled to only lump sum monthly consolidated remuneration as mentioned against each position. No other Allowances such as Dearness Allowance/House Rent Allowance/Medical Allowance/GPF/NPS and other allowances entitled for Government servant will be paid.
- v. Annual increment @3% shall be allowed during the term of the contract based on the performance.
- vi. Paid leave of absence may be allowed @ 1.5 days for each completed month.
- vii. The contractual engagement would be on full time basis and they would not be permitted to take up any other commercial assignment during the period of consultancy.
- viii. Application fee of **Rs. 500/-** for the said positions in the mode of **Demand Draft** made in favour of **Director**, **NIEPMD**, **payable at Chennai** need to be enclosed. SC/ST/PwDs and female candidates are exempted from payment of application fee.
- ix. The envelope containing application should be superscribed "Application for the positions of \_\_\_\_\_\_ (Consultant) at CRC A&N".
- x. Bringing in any type of Political/Official interference, influence, canvassing, other pressures in any form etc., will render disqualification of the candidature and action as deemed fit will be taken against such candidates. No correspondence in this matter will be entertained.
