Persons working with IITs who are educationally qualified and otherwise eligible can be considered for the recruitment up to a maximum age of 50 years.
- Persons employed in Govt./Semi-Govt. organizations/ Institutions should apply with due permission of their present employer and should produce a 'No Objection Certificate' (NOC) at the time of interview/ skill test, if called for the same. Applicants without NOC may not be permitted to appear in the interview/ skill test.
