- (i) **Name of the Post : ORIENTATION AND MOBILITY  
INSTRUCTOR CUM SPECIAL EDUCATOR**  
Category Reserved for: PwD (VI)

The only shortlisted candidate called for the recruitment process; bearing Roll Number OM/01 had appeared for the recruitment process for the said post on 07/04/2017. At the time of weightage calculation and verification of documents he had submitted three separate disability certificates, namely (1) Hearing Impairment (2) Visual Impairment and (3) Multiple Disability.

In view of three different disability certifications produced by the candidate; the external specialist (from the field of Visual Impairment) had suggested the selection committee to refer the case for review by a special technical expert committee comprising of experts from various fields of disabilities for their opinion; as the said post was not identified for Person with Multiple Disabilities.

- (ii) **Name of the post : SPECIAL EDUCATOR**  
Category Reserved for: UR

The Hon'ble High Court of Kerala, Ernakulam had given an interim direction to allow one of the candidates to appear for the written test held on 07.04.2017 and subject to the further orders of the Hon'ble High Court. Pending further legal opinion of the Central Govt Counsel (CGSC); the result of the said post is withheld.

- (iii) **Name of the post : WORKSHOP SUPERVISOR-CUM-  
STOREKEEPER**  
Category Reserved for : UR

The selection committee had decided for conduct of re-test; keeping in view of representation(s) of the candidates appeared for the said recruitment proceedings held on 07.04.2017, pointing out the inadvertent error of issuing the unused question paper for another post which was subsequently taken back and a fresh question paper was issued.





The committee also noted that the post(s) are sanctioned and created on regular basis by the Ministry of Social Justice & Empowerment, Govt of India.


The Selection Committee after detailed verification of the documents; credentials; weightage scores; performance of the candidates in the written exam has found that **Shri RANJEET KUMAR (Reg No.PO-03)** suitable for appointment to the post of PROTHETICS AND ORTHOTIC at CRC KOZHICODE on regular basis; with the usual terms and conditions; as applicable as per rules; with the initial pay applicable in the pay band PB2 with Grade Pay of Rs.4200/- in the scale of pay Rs.9300-34800 (pre-revised RPR, 2016).




