So the attached CAF has to be also signed. Request for an amendment to be made accordingly.	We accepted to sign the CFA after review and technically discussion terms & conditions mentioned in forms. However all mentioned terms & conditions may not be accepted.
	On page 6,point number 11(EMD),states that"All SSI/MSME units registered with NSIC /DGS&D /GeM for this item as per specification are exempted from the EMD". Have attached our MSME registration certificate, request confirmation as to whether this registration will be accepted.	Accepted
	On page 9, point number 22 states that "The ISP has to ensure minimum 99.5% uptime per month" and it goes on to say that if the uptime of 99.5% is not met then service credit as stipulated would have to be given and along with this when you read point number 23,titled Fault rectification schedule and penalties, it mentions a levy of penalty if the service is not restored within 30 minutes. We have 2 clarifications here, the 1st one is that there are 2 (point 22 & 23) penalties levied for the service not being up, normally it should only be 1,that is either point number 22 or point number 23 and our 2nd clarification is that to restore a link within 30 minutes may not be practical, since your office is located on the outskirts of the city.
